## **BACKGROUND:**

Administrative Order 282/21, effective September 28, 2021, mandated e-filing for all new actions brought by a provider of health services specified in Insurance Law Sec. 5102(a)(1) against an insurer for failure to comply with rules and regulations promulgated by the Superintendent pursuant to Insurance Law Sec. 5108(b). (No-Fault Actions).

Accordingly, the schedule for implementation of e-filing for all new "No Fault" actions is as follows:

October 6, 2021 - Kings County Civil Court

November 1, 2021 - New York County and Richmond County Civil Courts

November 22, 2021 - Bronx County and Queens County Civil Courts

Administrative Order 282/21 does not address No-Fault actions filed prior to the implementation of mandatory e-filing at the various Civil Court locations.

## **ADVISORY:**

As Administrative Order 282/21 does not address the electronic management of No-Fault Actions filed prior to the implementation of e-filing at the various Civil Court locations, conversion of preimplementation matters is guided by Rule 202.5b. As such, the Court will be converting all pending No-Fault matters previously filed in hard copy form to electronic form via the New York State Courts E-filing System (NYSCEF) pursuant to 202.5-b(b)(2)(iii)(iv), 202.5-b(d)(4), and 208.4-a(b).

Please note that although hard copy documents will be converted, it is necessary for parties to register for NYSCEF and record their representation on the NYSCEF site in each action for which they are a party.

Notice will be: (1) emailed to parties who have participated in training, and (2) posted on the NYSCEF and Civil Court websites.
